1. **Name of the Higher Learning Child Development Center (Daycare Center):** Sustainable Science Academy
2. **Same or different entity?** The subject academy is a totally separate entity from NWIAA Agriculture Outreach Center
3. **Why is the child care being opened?** OUR ' Children are failing in school and not being able to read by the 3rd grade. Dying and being incarcerated younger. It is URGENT that we teach them earlier and expose our youth to better through their environment. Information regarding our children failing came from the Oklahoma City Public School website; the horrific sad news was in the newspapers and on the local news television stations several times for years.
4. **Why is NWIAA taking such an interest?** Women that care, share and dare. It's a minority owned and operated business; a new generation of business women.
5. **What's unique and different about The Sustainable Science Academy's Higher Learning Child Development Center?** There is not another child care facility like this offered similar to this Academy in the state of Oklahoma.
6. **What does the Academy offer that is not offered in this community?**
 - Students without a learning disability will be taught how to read
 - How to properly speak English and Spanish
 - A clean, state-of-the-art facility with an outside agriculture class room
 - Locally grown fruits and vegetables for meals
 - Garden classes
 - Inside Gym health exercises
 - Sign language
